Execution Mechanism:

1- Procedure scanning Tribal : Done to set captivity target according to statements precedent It was completed wipe it and check Of which Previously according to Standards specific Which :

- A. capturing IDPs and Families Which host IDPs.
- B. Families Which she has Children Without Fifth or pregnant or lactating women
- C. Families Which she has Children Without age Fifth suffer From Ill nutrition atheism or moderate .
- D. Families Which support it woman or Child or Aged or Sick chronic or Individuals capturing suffer From disabilities physical.

- E. Families Which not she has origins productivity or means Enter trusted with it.**
- F. Families inside Societies The marginalized (the marginalized).**

2 - quantity of sacrifices required was determined according to the statements of the beneficiary families to whom the criteria apply.

3-Contracting with a livestock supplier:

A contract was made with the livestock supplier that established the internal practice, which included the purchase process and the slaughter of livestock in at least 2 slaughterhouses, according to strict conditions specified in the following:

- That the slaughterhouse includes sheds to receive live animals with capacities commensurate with the required numbers
- The slaughterhouse should include pens to isolate suspected animals
- The slaughterhouse should be surrounded by a concrete fence with a height of at least 2.5 m, and it has two gates, one for entering cars loaded with live animals and another for taking out meat, each equipped with a hole that cleans the wheels of cars.
- That the slaughterhouse include halls with suitable areas for slaughter and removal of limbs, skin, head and entrails.
- The slaughterhouse should include two slaughter lines, one for large animals (cows) and another for small ruminants (sheep, goats).
- That the slaughterhouse include places provided with hot water in a manner that allows for the disinfection of used knives and tools.
- The slaughterhouse should be well ventilated and lit, and its floors and walls should be made of materials that are easy to clean.
- That the slaughterhouse have sanitary units, changing rooms for workers, and places for purifying feet and hands.

- It is forbidden to smoke, spit and eat inside slaughterhouses and meat processing halls.
- To take into account, when slaughtering animals, taking measures and precautions that would reduce the harm caused to these animals, and to slaughter them according to the teachings of Islamic Sharia.
- The slaughterhouse must have a source of pure water in addition to a water tank with a capacity that is sufficient for the consumption of the slaughterhouse for at least two days.

After supplying sheep to the slaughterhouses that meet the specified conditions and standards, all the livestock were inspected before slaughter, which numbered 27 cows, 156 sheep, by the slaughterhouse veterinarian, as well as the meat was inspected after slaughter, and it was confirmed by him that all the livestock were healthy and free of any disease.
